1. FILL OUT APPLICATION. ALL NEW MEMBERS MUST BE SPONSORED. A MEMBER IN GOOD STANDING MUST SIGN THAT SECTION OF THE APPLICATION.

2. ALL NEW MEMBERS MUST COMPLETE AN ORIENTATION AND TRAINING COURSE BEFORE BEING ACCEPTED AS A MEMBER. DATES OF ORIENTATION AND TRAINING COURSES ARE ANNOUNCED ON THE EUNICE RIFLE & GUN CLUB FACEBOOK PAGE.

3. BRING COMPLETED APPLICATION TO THE TRAINING/ORIENTATION SESSION TO BE SIGNED BY INSTRUCTOR. SEND IN COMPLETED APPLICATION AND DUES TO ADDRESS ON APPLICATION.

EUNICE RIFLE AND GUN CLUB RANGE RULES AND REGULATIONS

The ranges are open **only** to **members, their immediate family and their guests**. You may **be challenged, so display your membership card on your person or on your shooting bench**. The guest(s) must be accompanied by the member. **No giving out of the combination to nonmembers.**

Gates are to be locked **at all times**. Close and lock gate behind you when entering.

A member may have only one guest with him on the range at any given time. Guests on the skeet range are not limited but must shoot in flights of no more than 5. The skeet facility is open to all members at all times. If other members wish to shoot allow them to shoot between your flights.

No one under 18 years of age will be allowed on the range unless accompanied and supervised by a member. Immediate family members are not considered guests and may **accompany** a member to the range at any time. Family is defined as persons living in your household. Members are responsible for the conduct, enforcement of club rules, collection of fees and safety of their guest.

Safe practices are always to be exercised. Firing is restricted to the target boards in the lane of the bench you are using. The rifle range bench tops are colored coded to match the lane you are in. There will be no firing at targets that are not in your lane (cross shooting). Failure to comply subjects the offender to immediate membership cancellation.

Members and guest are encouraged to wear hunter orange and use eye and ear protection when on the firing line.

The discharge of firearms on the range in other than designated areas is prohibited. This means firing is limited to targets placed on the range target boards and from the firing lines. This rule is to help contain all bullets within our range. These areas are the firing lines for pistol and rifle, along berm for shotgun patterning, and on the stations for skeet. **No going down range to shoot.**

The discharge of selective fire or fully automatic weapons is prohibited unless prior written authorization of the executive committee is obtained.

All weapons in caliber .50 BMG or larger are prohibited for use on the range. The use of armor piercing and steel core bullets is prohibited. The use of steel shot is prohibited. The use of explosives is prohibited. No shotguns except slugs are allowed on the rifle and pistol ranges. A shotgun patterning board is provided in the skeet area.

No one goes down range until all firearms are unloaded, actions open and firearms are placed on the bench. No one touches weapons while some one is down range.

No glass or steel targets. Targets must be cleaned up before leaving the range. All shooting must be done at targets attached to the target board. **Shooting at any targets on the ground or on the target frames is prohibited.**

Do not move or modify existing target boards. They are positioned to best prevent bullets from leaving the range when firing from the normal firing positions.

Destruction of club property is prohibited. This includes shooting of target boards with shotguns, shooting of post and target frames, signs and trash barrels.

Walk to check targets. **Driving on any part of the range by any type of vehicle is prohibited. This includes ATVs.** Vehicles may use the west boundary road if conditions permit.

Shooting while legally intoxicated is prohibited. Consumption of alcohol on the range is prohibited unless your shooting session is completed.

Each member is responsible for policing the range when they have completed firing. All spent shell and cartridges are to be picked up by the shooter.

Certain activities such as training, maintenance, dirt work, and organized events necessitate closing of the range. You may call (337) 580-4715 or (337) 457-1323 to see if the range is closed. You may also check our Facebook page.

Payment for skeet shooting is to be made by check and mailed to Eunice Rifle and Gun Club at P.O. Box 1054, Eunice, LA 70535. The charge is \$6.00 for each round. Fill out a voucher and leave the copy in the low house and mail the original with the payment.

Dues are \$125 for new members and \$100 for renewals per year. They are due in September of each year no matter what month you joined. **Members not renewing by Oct. 1 will be dropped from the rolls.**

Prospective (new) members must complete the training/orientation session before submitting their membership application.

Willful violation of the rules subjects the violator to suspension or expulsion from the club.
